

Annual Reports for 2017

The cover of this year's Annual Reports draws your attention to what your eyes behold every time you gather for worship – that beautiful stained-glass window of Jesus and the sheep (You will find details of the window featured in this collection of reports on the cover page for each section).

We are blessed to have this window that captures our attention every time we enter the sanctuary. Our eyes are drawn upward to the comforting image of Jesus who is standing among the sheep who, like us, also have their eyes drawn upward to the good shepherd (well perhaps not all are looking...but most are looking up even the lamb cradled in Jesus' arms).

This image speaks to us, comforts us, and reminds us that we are the sheep of God's pasture. The rod and staff in Jesus' hand comforts me and it also reminds me that like sheep we do go astray. Nevertheless, we are drawn back to the shepherd – moved by the grace of God.

It really is a very suitable image for our place of worship as it also helps define for us what worship is for and why our gathering for worship is so important. Like the window, Christian worship is about directing our eyes aright so that we might gaze toward the mystery of God and to be shaped by that mystery. And we need to worship, on a regular basis, because as human beings our gaze can be easily averted and distracted. Worship calls us back to God.

Now, what follows in the pages of these reports and the business of approving a budget may seem to have very little connection but the reports here touch on the various groups and gatherings we have at St. Andrew's. And each of the gatherings or meetings held by the people of St. Andrew's often begins with a time of prayer not to ask God to bless what we are doing or what we want to do but to be our guide. That is not to say our work is perfect (or that we should expect perfection) but prayer is the honest confession that we need God's help to worship, preach, pray, study, teach, work, toil, plan and be stewards of the gifts we have been given. We begin with prayer because we know we can become distracted...we know we are bound to get things wrong now and again. But the grace of God calls us back.

Now for most weeks your gaze is directed to the image of Jesus in the window...but my gaze is directed toward you and as I look upon you I am remind of my calling. Looking at you and serving you has shaped the words I speak, the prayers I offer, and in the soon to be eleven years with you, you have truly shaped me into the minister that I am. As I look out and see you I am filled with gratitude for what you offer, for how you have shaped me and this community of faith and I am grateful that together we can serve and together gaze toward the mystery of God so that we might be drawn closer to God and to one other in Christ.

MINUTES OF THE ANNUAL CONGREGATIONAL MEETING St. Andrew's Presbyterian Church Sackville, New Brunswick

Place and Time

The Congregation of St. Andrew's Presbyterian Church, Sackville, New Brunswick held its annual meeting at the church on Sunday, February 5, 2017 at 12:45 in the afternoon. In gathering to meet, we acknowledge that the land on which we gather is the traditional unceded territory of the Wolastoqiyik (Maliseet) and Mi'kmaq peoples.

Opening Devotions:

Rev. Murray, Chair, opened the meeting with the reading of 2 Corinthians 9:6-15, followed by prayer.

Secretary:

It was moved by Richard Fillmore, seconded by Art Miller, that Sylvia Harris serve as Recording Secretary for the Annual Congregational Meeting. Carried.

<u>Agenda:</u>

It was moved by Paul Bogaard, seconded by Donna Capper, that the Agenda be adopted. Carried.

Minutes:

It was moved by Mary Bogaard, seconded by Art Miller, that the minutes of the Annual Congregational Meeting held on February 14, 2016 be adopted as distributed. Carried.

2016 Reports:

It was moved by Mona Meldrum, seconded by Anne Miller, that the following 2016 reports be adopted as distributed: Atlantic Mission Society and Ladies' Aid, Atlantic Mission Society Financial Report, Board, Church School, Flower Committee, Food Bank, Garden, Greeting & Reading, Ladies Bible Study, Music Support, Publications Committee, Session, St. Andrew's Library, Social Committee, and Teddies for Tragedy. Carried.

Nominating Committee Report:

It was moved by Julie Comeau, seconded by Laura Snyder, that the Recommendations 1 to 7 be adopted by consent. Carried.

- 1. That Art Miller, Kirk Meldrum and Linda Trentini be appointed to the Board of Managers for a three-year term (2017-2019).
- 2. That Art Miller be re-appointed as Chair of the Board of Managers for 2017.
- 3. That Anne Miller be re-appointed as the church Treasurer for 2017.
- 4. That Alex Whitla be re-appointed as Secretary of the Board of Managers for 2017.
- 5. That Elizabeth Millar be appointed Envelope Secretary for a one-year term (2017).
- 6. That Brian Johnstone be re-appointed as the Financial Reviewer for 2017.
- 7. That Kirk Meldrum be re-appointed as a Trustee for St. Andrew's for a three-year period (2017-2019).

It was moved by Mona Meldrum, seconded by Mary Bogaard, that all other nominations and the report as a whole of the Nominating Committee be adopted. Carried.

Rev. Murray pointed out a new position created for this year, Assistant to the Treasurer, which will be filled by Darya Tower.

Financial Reports and Review:

Rev. Murray called upon Anne Miller to present the financial statements. Before she did so, Art Miller suggested that the motion regarding the review letter from Brian Johnstone be dealt with first. The meeting agreed.

It was moved by Art Miller, seconded by Anne Miller, that the review letter from Brian Johnstone, Financial Reviewer, be received. Carried.

It was moved by Anne Miller, seconded by Donna Capper, that all Income and Expense statements for 2016 be adopted as presented. Carried.

It was moved by Anne Miller, seconded by Paul Bogaard, that the Balance Sheet for 2016 be adopted as presented. Carried.

It was moved by Mona Meldrum, seconded by Brian Neilson, that the session recommendations for donations totaling \$1,625 and Presbyterians Sharing allocation of \$9,566 be approved. Carried.

It was moved by Anne Miller, seconded by Mary Bogaard, that the Budget for 2017, totaling \$119,600 be approved. Carried.

Rev. Murray offered thanks for the work of the Session and gave the lengths of time each elder has served, noting that Mary Bogaard has served for the longest time, at close to thirty years. This announcement was followed by applause.

Mary Bogaard then thanked Rev. Murray for another year of fine and inspiring sermons and for his leadership of the congregation. Applause was given.

There being no further business, Rev. Murray called for a motion to adjourn.

It was moved by Donna Capper, seconded by Julie Comeau, that the meeting be adjourned.

Rev. Murray closed the meeting with prayer at 1:45 p.m.

Projects supported financially during the year were The Arise Ministry in Toronto with Rev. Deb Rapport, Servant Partners, Camp Geddie, World Vision, Presbyterian World Service and Development (PWS&D), St. Andrew's Hymn Book Repairs, Open Sky and Teddies for Tragedies.

As our foster child Vatimetou Mint Alliyin reached the age where she no longer receives sponsorship, it was decided to no longer support a foster child but rather to send a general donation to World Vision for this year.

As mentioned in the "Salt" it was a pleasure to attend in March the World Day of Prayer Service at "the old grey church in the wood" during the 200th Anniversary year of St. Ann's Anglican Church in Westcock. The service was written by women of the Philippines.

The members led the Mission Awareness Sunday Service which, was held on April 30, 2017.

At our September meeting we were pleased to listen to Terrlynn Allen speak about the work of the Port Elgin and District Voluntary Action Council (PEDVAC). It is a vibrant organization providing supplementary and emergency food, Christmas boxes, a garden, a teaching kitchen, children's activities, literacy training, resource referrals and a community boutique. The council began in 1984 and is well known for their mitten fundraiser, "Warm your Hands and your Heart."

The AMS Annual Meeting was held from September 15-17 in North Sydney, NS. Sylvia Harris attended as our delegate.

The AMS Fall Rally of the St. John Presbyterial was held on October 14, 2017 and was hosted at our church. Rev. Don Shepherd and Judy Hetherington travelled from Saint John to attend. The speaker was Abby, a lovely young women working with InterVarsity Christian Fellowship in Fredericton. She was a graduate of Mount Allison University and learned about their work here in Sackville.

A Christmas Craft Sale was held on November 26, 2017 and raised \$400 which was evenly split and donated to Servant Partners and Open Sky.

Rooted in Love, the 2017 Women's Gathering, organized by The Women's Missionary Society (WMS) was held in Richmond Hill, ON, from May 19-22, 2017. Sylvia Harris attend the event.

We were very pleased to welcome a new member, Helen Amos in December when we gathered at the home of Eileen Smith and enjoyed a time of Christmas sharing and refreshments.

SESSION REPORT

The Session met regularly during 2017, and the meetings were well attended.

The Sacrament of Holy Communion was celebrated on seven Sundays, with an average of 33 people partaking of the sacred elements. The Lord's Supper was also celebrated on the evening of Maundy Thursday and the late evening service on Christmas Eve.

During the service on Easter Sunday, April 16, a service of baptism was held for Travis, Merrik, and Sophie Tower. A service for the affirmation of baptism was held for Alice and Charles Torrance, and Darya Tower. Travis Tower, Darya Tower, Alice Torrance, and Charles Torrance were added to the Membership Roll.

There were a number of changes among the elders in Session during 2017. On the first Sunday in February, three members were ordained as elders and welcomed to the Session: Terrlynn Allen, Donna Capper, and Laura Snyder. During that service we also expressed our sincere appreciation to Sylvia Harris for her dedicated work as Clerk of Session, as she had recently resigned from that position. Several elders served as acting clerks in the interim, until Laura Snyder agreed to step into that role in May.

Sylvia held a number of responsibilities that have now been distributed among elders. Lew Clarke was named our Representative Elder, and Brian Neilson is serving as the alternate. Linda Trentini now has responsibility for Church bookings. Mona Meldrum is the new Roll Clerk and also has responsibility for the District List.

It was with great regret, but also with abundant thanks for her years of dedicated service, that we accepted Sylvia's resignation from Session, effective at the end of June, 2017. In August we accepted Donna Capper's letter of resignation from Session, as she and Michael moved to Ontario. Their service and their presence will be greatly missed here at St. Andrews.

Mission Awareness Sunday took place on April 30th, with the theme "Disciples of Christ." Members of St. Andrew's Auxiliary of the Atlantic Mission Society took part in the service.

We welcomed several guest preachers to our pulpit this year. During July, April Griffin shared

with us the ministry of "Servant Partners"; services were also led by Samuel Landry (student intern in the Anglican parishes of Sackville and Dorchester), and Rev. Dr. Elizabeth Wells (Deacon at St. Paul's Anglican Church). On October 22 we welcomed guest preacher Rev. John Perkin, Mount Allison University Chaplain. The guest preacher for our Anniversary service on November 5 was Rev. Dr. P. A. (Sandy) McDonald (St. Andrew's, Dartmouth, NS).

On May 14th, during Coffee and Conversation, Barbara Jardine shared her experiences in Bahrain.

During the fall, Rev. Murray led a study on the book Sabbath as Resistance: Saying No to the Culture of Now, by Walter Bruggemann. This thought-provoking book generated lively conversations during discussion sessions.

Following the service on November 19, Rev. Murray led a congregational Forum on Human Sexuality, to consider the matter currently before the Presbyterian Church in Canada. Study documents and a survey from the PCC Committee on Church Doctrine and the Life and Mission Agency were shared prior to the forum. The forum included discussion in small groups, facilitated and recorded by several elders.

St. Andrew's continues to be involved in the support of refugee families within the Sackville community. One important initiative during 2017 was the private sponsorship of Abdel Jabbar, the brother of Nizar.

We give God thanks and praise for all His wonderful work among us during 2017, and we pray that he will continue to bless us and the ministry we share together.

CONGREGATIONAL COMMITTEES - TERM OF OFFICE AND DUTIES

Annual Meeting Officials:

<u>Chair</u> - "At congregational meetings the minister of the congregation, or the minister appointed by the presbytery, presides. But if the minister is absent or declines to preside, the meeting appoints one of its number to take the chair" (Book of forms 154). Duties: Calls the Annual Meeting to order. Conducts the business of the Annual Meeting in an orderly and expeditious fashion. Assures that all motions are properly moved, seconded, debated and voted upon.

<u>Secretary</u> – Appointed annually. Duties: Records the minutes of the Annual Meeting to be reported to session and to the Board and recorded for the next Annual Meeting.

Board of Managers:

Consists of no less than six and no more than eight members nominated by the congregation, plus one member of the Session, appointed by the Session as liaison member. "One-third of the board shall retire each year by rotation, and their places, as also the places of any who vacate their office during the year, shall be filled at the annual meeting. The retiring managers may be re-elected" (Book of Forms 159).

<u>Chair</u>- "Appointed by the congregation at its annual meeting from among the members of the board. If this is not done, the board appoints them at its first meeting held after the annual meeting" (Book of Forms 167). May be re-appointed. Duties: "have each meeting opened and closed with prayer. See that business is properly ordered and recorded; to take the vote; and to announce the decisions. He/she may introduce any business to the Board, and may speak regarding it, but has only a casting vote. As the executive of the board, he/she also has power to perform any functions explicitly assigned to him/her. In the absence of the convener from any meeting of the board, one of the other managers may be chosen to preside" (Book of Forms, 168.)

<u>Treasurer</u>- "Appointed by the congregation at its annual meeting from among the members of the board. If this is not done, the board appoints them at its first meeting held after the annual meeting" (Book of Forms 167). May be re-appointed. Duties: "to keep the accounts of the congregation, together with all vouchers; to receive and disburse all moneys subject to the direction and control of the board; and to produce his/her accounts, properly audited, to the annual meeting of the congregation. Where there is a chartered bank convenient to the congregation, it is the duty of the treasurer to deposit therein, without delay, all money received by him/her, and in a separate account identifying it as belonging to the congregation" (Book of Forms 170).

<u>Assistant to the Treasurer</u> – Appointed by the congregation at its annual meeting. Person assists in the overall work of the treasurer position.

<u>Secretary</u> - "Appointed by the congregation at its annual meeting from among the members of the board. If this is not done, the board appoints them at its first meeting held after the annual meeting" (Book of Forms 167). May be re-appointed. Duties: "to keep a faithful record of the proceedings of the board; to engross therein the record of any congregational meeting held for temporal purposes; and to take charge of all papers belonging to the board that are not entrusted to the custody of the treasurer. The minute book shall be available to the board at all times, and shall be signed by the convener and secretary" (Book of Forms, 170).

Envelope Secretary: Appointed annually at the Annual Meeting. May be re-appointed. Duties: Verify and record the totals of offerings received. Prepare income receipts quarterly. Maintain the envelope holder number file.

Reviewer: Appointed annually at the Annual General Meeting. May be reappointed. Duties: Review the Church's financial records annually.

Trustees:

Three members appointed for three year rotational staggered terms; must be professing members of the church (Book of Forms, 149). Duties: Hold the property of the congregation in trust as provided for in the trust deed.

Social Committee:

Six members appointed for three year rotational, staggered terms.

Duties: Plans and is responsible for all congregational social and fellowship activities. Social Convener is responsible for organizing and supervising catering arrangements for congregational events, including monthly Coffee and Conversation.

Library & Archives Committee:

Three members appointed for three year rotational staggered terms. May be reappointed for a second term. Duties: set policy for the Church Library in consultation with the Session when appropriate. Purchase new materials in consultation with the Minister. Accession and classification of new materials. Maintain the collection in an orderly fashion. Encourage use of the library by the congregation.

To collect and deposit in the Mount Allison archives the archival record of the congregation.

Publications Committee:

Five members, appointed for rotational staggered three year terms. May be reappointed. Duties: For Newsletter - plan, edit and publish on a regular basis.

For Congregational Directory - to gather information, edit and publish annually.

For Webmaster - supervise setting up and maintenance of church web site.

Flower Committee:

Two (or more) members, one being the chair, appointed for 3-year terms. May be re-appointed. Duties: Providing weekly flower arrangements in the Church, either live materials, potted plants or dried/artificial floral material depending upon availability. Coordination of floral memorials with donor, receiving requests and arranging for purchase and placement as required. Notify Minister of memorial so that acknowledgement can be made from the pulpit or in the bulletin. Arranging cards and flowers for special events within the life of the congregation - Christmas, births, marriages, illness, deaths, etc.

Greeter Coordinator:

Appointed annually. Duties: to co-ordinate and remind two persons per Sunday to act as greeters, ring the bell, and take up the offering.

Reader Coordinator:

Appointed annually. Duties: to co-ordinate and remind persons to read Scripture lessons during weekly worship service and special services.

Communion Elements:

Appointed annually. Duties: to prepare communion table and elements for the purpose of celebrating the Holy Communion as directed by the Session.

Community Association Representative:

Appointed annually. Duties: Represents the congregation on the Sackville Community Association.

Nominating Committee:

Three members appointed for three year rotational staggered terms. The chair is senior member of the Committee. Duties: prepares a list of candidates to serve on various Church committees and boards, other than those appointed by Session.
