“Emmanuel”

A name for Jesus the Messiah given to us in Matthew’s Gospel is a name that offers comfort and good news ~ Emmanuel meaning “God is with us”.

The best thing about that promise contained in the name is that it is not conditional! It is not “God is with the rich, the happy, those who are whole, those who are righteous, those who are like us, or live our kind of lifestyle, or vote the way we vote, and think the way we think”. Those conditions would suggest that God is then “not with” others in this world. There is no “if” added nor is there fine print suggesting some conditions apply.

Again Emmanuel is not a promise with conditions but from the very beginning a promise to all. That is especially good news to us when we feel we don’t measure up or don’t fit in - God is with you. It’s is good news for those who are going through times of trial, darkness, sadness - God is with you too!

God did not enter the world to be with the perfect, or a select group, or even those on his side. Nope! He entered to be with us all.

May this season be a reminder that God is with you, with us, with all!

What is a Christingle?

It is a symbolic object we make to help us celebrate and symbolize Jesus Christ as the Light of the World in our Christian faith. It is composed of an orange, a white candle, red tape or ribbon and small sweets on cocktail sticks. Christingle services originated in Moravia, in Germany in the 18th century, and now, in the United Kingdom, are a part of the yearly traditions over the Christmas period in many churches.

The orange represents the world. The red ribbon or tape around the orange is for the love and blood of Jesus Christ. The white candle reminds us of the light that Jesus brings to the world. The little marshmallows and fruits stuck into the orange with cocktail sticks are meant to show the four seasons as well as the fruits of God's earth. When we light the candles, we spread the light that Jesus Christ brings to the world, that gives hope to people living in dark times.

The Christingle is usually made by children to help teach them about Jesus. But at St.A's, we can all join in making the Christingles on December 11 during Coffee and Conversation, and have a brief service when we dim the lights, light the candles and have a prayer of thanks for the one who is The Light of the World.

Our overall finances look healthy at this point in the year. We have had two congregant's full year donations up front, an unexpected bequest, and the CEBA loan money to help us. In addition, we have held a drive for the ROOF FUND, which has brought in over \$13,000 from congregation and friends. Combining this with the CEBA money and the bequest, we have over \$40,000 right now to set aside for the roof. Once we have a firm quote and roofer, we will decide whether we need to raise more money for it or not—we want one that will not blow off!

The B & R Account is bloated right now with all the moneys mentioned above, which will go towards our new roof. But some funds in B & R are having to be used for the shortfall in Operating (loss of \$3,409 there). We need to keep "Local" (Operating) donations UP!

Memorial Account

The Memorial Account has a balance of about \$5,600 now, of which \$1,080 is, at present, the amount reserved for the Benevolent Fund. \$8000 was spent from this account for video equipment, but the fund recovered with donations upon the passing of Bertha Fillmore.
